Motion in Support of Pro Hac Vice Application

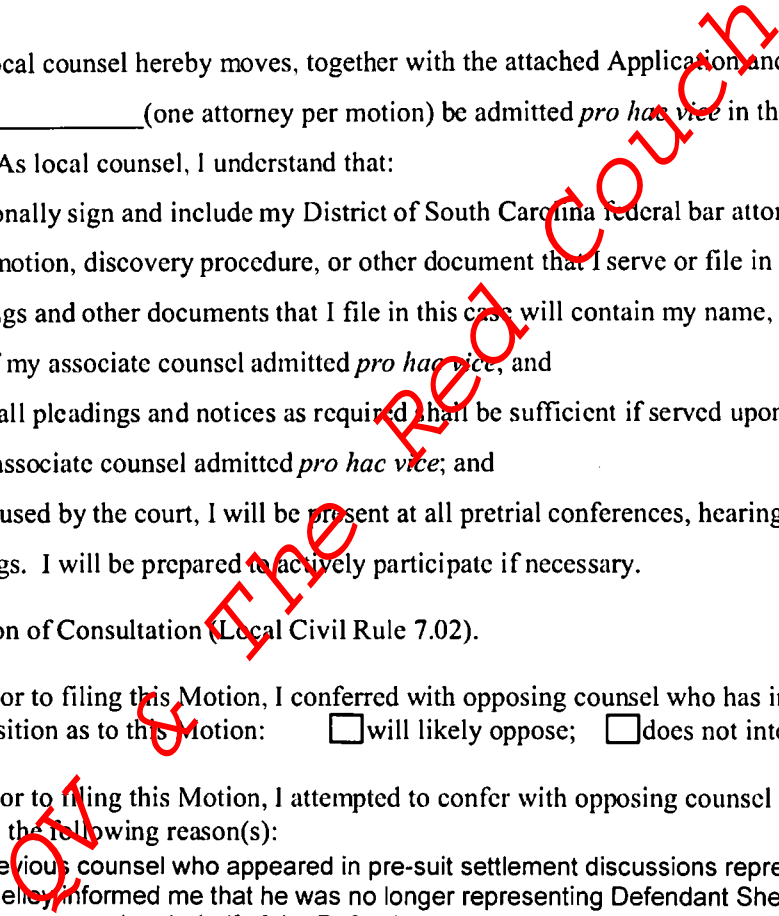
