
Motion To Intervene As Plaintiff under Fed R. Civ P. 24(A)2, 24(B)
Motion For Brief of Amicus curiae, friend of the court
Motion For reconsideration & clarification

Comes now the Intervenor, Movant, Jonathan Lee Riches d/b/a Gordon Gekko, moves this Honorable Court to Intervene as a Plaintiff in this case under Federal rules of Civil Procedure rule 24(A)2 - as a unconditional matter of right, or under rule 24(B) - permissive intervention, Zuber v. Allen, or in the Alternative moves this court for Brief of Amicus curiae, friend of the court. I have an interest in this case to support Arthur's claims and I have newly discovered evidence to provide this court as a friend. My Intervention brings questions of Law and Facts that are common in this action. Defendants are linking me with Anna Nicole Smith, The Howard Stern show, aired false information about me in 2002, that said I was sexually involved with Anna Nicole Smith and I committed Identity theft and Fraud to finance Smith's L. Pestyle. Then KPRC Houston tried to interview me while I was at the Fdc Houston Federal detention center in June 2003, to ask me about me doing cybercrime and using Ebay fraud proceeds to buy Anna Nicole Smith suits sthque dresses, her Gucci purse, that Anna wore on her Anna Nicole Smith show on the

E network, KPRC Houston sent me 5 media Request interviews while I was at FDC Houston, and on June 17, 2003, they aired pictures of me and Anna Nicole on the 5 o'clock news. Pictures of us kissing in front of Mt. Rushmore, they showed Bank surveillance photos of me doing illegal credit card wire transfer cash Advances at Bank of America with Anna next to me smiling, and they played Audio tapes of Anna Nicole begging me to use a stolen capital one credit card to buy her Avon products and high heels. I have all the photos in my possession, but on Aug 10, 2003, defendant's CBS Studios Inc & TMZ.com had a secret arrangement with my cell mate Julio at FDC Houston, to break into my cell locker and steal personal love letters Anna Nicole wrote to me and sexual explicit photos of us together. Defendant's bought the photos from Julio for \$75 thousand and the TMZ.com posted them online and CBS 60 minutes Leslie Stahl began harassing me in person for interviews. Then CNN news got evidence from the FBI linking me to doing credit card fraud and Mortgage fraud with Anna Nicole and other celebrities, i.e. Sean P. Diddy Combs, Vengaboys, Billy Joel, Adam "Pacman" James. CNN Producer Andy Seay produced a show on me titled CNN Presents "How to Rob a bank" played on May 20, 2006, It was also repeated today on 10-26-08 at 6am. The show said I did computer hacking, phishing, and stock fraud to finance Anna Nicole Smith's wild lifestyle. It said I used Jenna Jamison's information, and made Anna Nicole a fraudulent drivers License in Jamison's name, and we used that license to get Breast implant surgery for Anna Nicole from the same doctor who performed surgery for Kanye West's mother in Mexico. It costed \$18 thousand. We got it on credit, we also got a \$6 thousand tummy tuck and In May 2002, we used Janet Reno's stolen American express, so Anna Nicole could get a \$5 thousand tummy tuck Lipo and electrolysis on her legs by a Boca Raton, FL Surgeon. In Oct, 2002, I introduced Larry Birchhead to Anna Nicole, Larry was my cybercrime partner in crime. Defendants Howard Stern said that I used stolen American Express checks to pay for Birchhead's hair transplant through Bosely's Hair center, and blond streaks to go with it. I used Identity theft money to purchase Bahama trips for Birchhead and Anna Nicole and I, where

we partied the night away in Nov 2002 for 3 weeks. KPRC in Houston, lied, they said I bought ex. pills, cocaine, and grey goose with stolen Discover credit cards, and posted photos of me and Anna Nicole in Nassau Bahamas at Sandals, at the pool side, doing cocaine with a umbrella straw, these pictures were false and digitally imaged. Then Howard Stern came out with a bogus story, me and Anna Nicole got married at a vegas chapel of Love with Britney Spears as a witness, and Eva Longoria as Anna Nicole's Bridesmaid, Defendants claim all the wardrobes Anna Nicole wore on her E network Anna Nicole Smith show was bought by me for her using stolen credit cards from other hollywood Actors I obtained through a broker deal with LA spy Anthony Pellicano. This is a lie I admitted only in my Federal plea bargain case in Houston, that I spent only \$500 thousand of stolen money for Anna Nicole between 2001 and Jan 2003. I've been insured because of these false reports, defendants continue posting Internet blogs and stories linking me to fathering Anna Nicole's child, having Adopted a Mexican boy with Anna Nicole when we did credit card fraud in Cancun, when we stayed at Howard Johnsons, I move this court for Amicus Curiae, friend of the court, to provide newly discovered evidence, I get harassed At FCI Williamsburg by tabloids, newspapers, the Jon Stewart show, Matt Dudge trying to get the big scoop on me and Anna Nicole. I do admit, I still having clothing belonging to Anna Nicole, Victoria secrets, and Home depot tools, but I plan to sell them on ebay when I get out of prison. I move for a motion for reconsideration. I hold Anna Nicole & my co-defendant Stefanie Costley Doyle liable for me being in prison for fraud, I did crime for them, see where it got me, I was trying to impress women, I'm never going to touch a stolen credit card again, Its my constitutional right to whistle blow in this case. I pray this honorable court for relief

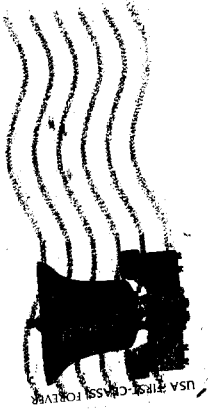

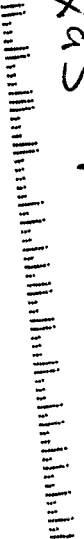
