

That is fine, they included links to the site, but what she did next could very well cost the case ... she decided to uncover a piece of infomraiton that is yet to be confirmed .. keeping in mind it is but ONE piece of the puzzle int he case to protect precious it is a BIG piece ... Von rushed to put this piece of unverified information on her site knowing it was not FACTUAL and did not have the appropriate credits (((due to the orginal author))) My email and msn between her was to ensure to keep the authors name on the pice of info to ensure she did NOT get dinged with a legal suit. (((if anyone wants to see THOSE emails I can provide such since to this moment Von is denying any contact with me in those regards)))

Not once have i ever take credit for any information passed along to me.. how could i when the information that shows up in my inbox gets FORWARDED immediate to the appropriate ppl (((meaning its not my email that shows where the information has been recieved from)))

Dont get me wrong I do my part of information but as such being in Canada many sites are blocked from me gaining access.

So when von removed the thread i was not home .. when i got home ... i was blocked from the site and chat .. hence making life very confusing as to what happened .. keeping in mind i have talked on the phone with von practically every day for over a month. She has always been in the "loop" as to what I do for the case and appreciated the fact that I could assist on her site but also to ensure that much fo what was being done on my end remain quiet.... the ones that have offered information are in the know that i have a direct line to the lawyers

What does hurt the most is i did not recieve an email from Von until late friday afternoon, in which case she proceed to place blame on me for her poor choice of action.

I did reply to clarify that I was unaware fo whom contacted her since really that is none of my business, but that I was questioning why her appointing blame to me was justified, this resulting in teh chat logs i have been sent.

So really, IN MY OPINION, i think von made a poor choice to reveal soemthing she KNEW was sensitive, and that her motives on the outside could be viewed as "limelight" seeking, or maybe she just wanted to be the first to air it... but sadly all the work that has been involved in protecting daniellynn can not be jepordized by another who is not on the same page.

If if were you in possession fo such sensitive information would you place it before the public eye? Or would you send it on and hope that it helped the people that are working to make a case to protect her ((meaning the LAWYERS NOT ME))))

So if my being Vons scape goat is what the members of the site are going to go along with .. so be it .. but at the end of the day .. my part has always been honest and pure, my passing the information to the lawyers is but one part of a TEAM, a team that should not demand media attention for what they offered to do to help....
