

AGREED ORDER

On this day came on to be heard on submission Defendant Nelda “Rose” Turner’s and Plaintiff Virgie Arthur’s Agreed Motion for Entry of an Order (the “Motion”). Proper notice was given to all parties. The Court considered the motion and all responses and replies of counsel and pro se parties. The Court is of the opinion that the Motion is in all things proper and should be **GRANTED**. It is therefore

ORDERED that the authority of the Special Master previously appointed by this Court is expanded to include the assignments reflected in this order. It is further

ORDERED that defendant Nelda “Rose” Turner (“Turner”) turn over to the Special Master all hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information in Turner’s personal possession and control to Special Master Craig Ball for examination. For the purpose of this Agreed Order "Electronically Stored Information" is defined in the same way it is defined in Plaintiff’s First Request for Production to Defendant Nelda Turner. It is further

ORDERED that plaintiff Virgie Arthur will arrange and pay for the storage devices to be picked up and delivered to the Special Master and for the storage devices to be delivered back to Turner. It is further

ORDERED that the Special Master is to image all information of which the Special Master will keep one copy for the duration of this suit and provide Turner with a copy of the image made of the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information turned over to him by Turner. It is further

ORDERED that the Special Master is to return to Turner as soon as possible the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information which were turned over to the Special Master by Turner. It is further

ORDERED that the Special Master is to reproduce all documents from the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information turned over to him by Turner which constitute communications, including but not limited to email and other electronic communications, for the period September 20, 2006 through the present, between Turner and:

It is further

ORDERED that Turner is to forward to the Special Master a copy of the Terms of Use and Service ("TOS") and the Privacy Policy of RoseSpeaks.com and the Special Master is to use these in determining which documents are to be reproduced from the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information turned over to him by Turner. It is further

ORDERED that the Special Master shall provide Turner with a copy of all documents reproduced from the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information turned over to him by Turner. It is further

ORDERED that Turner will have twenty-one (21) days from her receipt of the copy of all documents reproduced from the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information turned over to the Special Master by Turner to prepare a privilege log (the "Privilege Log") which provides the information

set out in Rule 193.3(b) of the Texas Rules of Civil Procedure, and to provide the same to the Special Master and counsel for plaintiff Virgie Arthur. It is further

ORDERED that twenty-five (25) days after Turner's receipt of the copy of all documents reproduced from the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information turned over to the Special Master by Turner the Special Master shall provide copies of all documents reproduced from the hard drives, flash drives, jump drives, DVDs, CDs and other similar storage devices containing Electronically Stored Information turned over to him by Turner which were not listed on the Privilege Log. Nothing in this order will prevent plaintiff Virgie Arthur from challenging the withholding of any document, which Turner claims to be privileged. It is further

ORDERED that plaintiff Virgie Arthur will bear the costs, including the Special Master's fee and the Special Master's expenses, for the Special Master to perform the tasks set out in this order.

All relief not expressly granted herein is **DENIED**.


